

Visitor Terms and Conditions

These are the general terms of agreement for visitors of the LEGAL ®EVOLUTION Expo & Congress 2023 (the “Event” organized by LEGAL ®EVOLUTION GmbH (the “Organizer”), which will be held 3 and 4 May 2023 in Nuernberg, Germany.

1. Visit of the Exhibition and Congress

1.1 The Organizer may reject any registration for any reason within nine days of a visitors registration for the Expo & Congress and/or the Networking Dinner & Party. If the visitor has already paid the registration fee, the rejection becomes effective only upon repayment of the registration fee.

1.2 For the visitor to have admission to the event, check-in at the registration counter in the entrance area is necessary. At the organizer's request, the visitor must present a photo ID (e.g. passport, identity card, or driving license). At check-in, visitors receive a personalized visitor badge, which serves as proof of registration throughout the event.

1.3 The Organizer reserves the right to escort anyone from the Event premises who, upon request, does not show proof of his registration or does not comply with the policies outlined in these Terms and Conditions, as well as to prevent their reentry. Should this occur, the Organizer will not refund the registration fee.

2. Additional options and discounts

2.1 Registration in the Expo & Congress Ticket category allows participation to get all access, including Expo, workshops and lectures, catering and evening event. Use the registration option on the Internet for your registration. You will then receive a registration confirmation and invoice. Please make sure to transfer the invoice amount, stating the invoice number, before the start of the event.

Included in the registration fee:

The conference fees are exempt from VAT

By registering and paying the participation fee, you are entitled to the following benefits:

- Participation in the Expo & Congress
- detailed congress documents
- lunch on all two Expo & Congress days
- Refreshments at the designated coffee bars

- Visit to the accompanying trade exhibition
- Participation in the After-Work Hangout on May 03, 2023.

Should the capacity of the premises be exceptionally limited, we will ensure an adequate live transmission of the lectures at the coffee bars.

2.2 To utilize the Student Education Program, the visitor must be an active full-time student, full-time doctoral student or articulated clerk at the time of the event.

2.3 Special conditions for groups and LR Ambassadors ticket on request.

3. Cancellation Policy and Transfer of Registration

3.1 Please understand that cancellations must be made in writing. For booking changes due to incomplete or incorrect participant information, a processing fee of EUR 50,- will be charged. For cancellations till April 15, 2023, a cancellation fee of EUR 150,- will be charged. The visitor can either request an equivalent ticket for the next LEGAL[®]EVOLUTION event or a refund of the registration fee less a processing fee of 15 percent.

For cancellations after April 15, 2023 and for no-shows, the full fee will be charged. In case of prevention, a substitute participant can be named in writing.

3.2 Tickets, in the categories Expo & Congress, can be transferred to another person before the start of the event. The initial visitor can send the organizer an e-mail with the new visitor's information to Info@LEGAL-REVOLUTION.com. The organizer has the right to reject the transfer upon reasonable grounds. By transferring or by participating in the event, the

4. COVID-19-related cancellation, force majeure

4.1 The Organiser reserves the right to cancel the event in whole or in part (for example, only the physical event) for reasons related to the COVID-19 virus, for example, because fewer visitors than expected have registered due to COVID-19 or because the Organiser reassessed the risk situation. The cancellation is considered as a withdrawal from the contract(s) between her and the visitor.

The visitor may withdraw at any time up to the beginning of the event for these reasons.

4.2 The event may be cancelled for the following reasons, among others: Force majeure, such as, war, terrorist attacks, natural disasters, insurrection, strike, by law, or for any other reason for which the organizer is not responsible.

4.3 If the event does not take place for one of the reasons stated under Item 4.1, the Organizer will credit the registration fee for this event to the registration fee for the next planned LEGAL[®]EVOLUTION Expo & Congress.

5. Data Protection and Privacy Policy

5.1 By registering, the visitor agrees that sound and film recordings or photographs may be made of him and used in connection with the event in print media, radio, and on the Internet.

6.1 The organizer is not responsible and is not liable for damages caused by anyone other than the organizer itself, its legal representatives or vicarious agents.

6.3 If a visitor damages a third party, the visitor is obliged to release the organizer from all claims made against the organizer based on these damages.
